Amend the resolve by striking out the title and substituting the following:

**'Resolve, Establishing the Maine Council on Competitiveness'**

Further amend the resolve by striking out all of the emergency preamble.

Further amend the resolve in section 2 in subsection 2 in paragraph E in the first line (page 2, line 4 in L.D.) by inserting after the following: "Maine" the following: 'State'

Further amend the resolve in section 4 in the next to last line (page 3, line 15 in L.D.) by striking out the following: "June" and inserting in its place the following: 'October'

Further amend the resolve in section 8 in the last line (page 3, line 43 in L.D.) by striking out the following: "." and inserting in its place the following: '; and be it further'

Further amend the resolve by inserting at the end before the emergency clause the following:

**'Sec. 9. Appropriation. Resolved:** That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
