Further amend the bill by inserting at the end before the statement of fact the following:

## **'FISCAL NOTE**

The Bureau of Motor Vehicles within the Department of the Secretary of State will incur some minor additional costs to provide organ donor decals and administer this program. These costs can be absorbed within the Bureau of Motor Vehicles' existing budgeted resources.'

## STATEMENT OF FACT

16 This amendment requires the Secretary of State to provide organ donor decals at no additional fee. The statement regarding willingness to make a gift is to be printed on the decal. It also allows the Secretary of State to continue to use decals 20 already printed.

22 The amendment also adds a fiscal note to the bill.
