"**§5111-B.**" in subsection 3 in the 6th line (page 2, line 10 in L.D.) by striking out the following: "<u>\$614,625,000</u>" and inserting in its place the following: '<u>\$674,230,000</u>' '

Further amend the amendment by striking out all of section 2 6 and section 3.

Further amend the bill by inserting at the end before the statement of fact the following:

'FISCAL NOTE

14 This amendment establishes a target revenue amount of \$674,230,000 in fiscal year 1996-97, the amount currently budgeted for General Fund revenue from individual income taxes in fiscal year 1996-97. This will eliminate the reductions of budgeted General Fund revenue during the 1996-1997 biennium. However, if actual General Fund revenue exceeds this amount during the fiscal year, that excess amount must be set aside into the Revenue Targeting Fund.

This amendment eliminates the General Fund appropriation to 24 the Bureau of Taxation. This bureau will require this appropriation in fiscal year 1997-98. The allocations from the 26 Revenue Targeting Fund are also eliminated. Distributions from the fund will not occur until fiscal year 1997-98.'

STATEMENT OF FACT

This amendment changes the target revenue amount to \$674,230,000 and begins the Revenue Targeting Fund process in fiscal year 1996-97.
