2 STATEMENT OF FACT 4 This amendment removes the unconstitutional limitation on the Legislature's power to enact, amend or repeal the statutory list of endangered and threatened species. The limitation had 6 required the approval or recommendation of the Commissioner of Inland Fisheries and Wildlife in order for the Legislature to 8 enact, amend or repeal the statutory list. 10 The amendment provides that the Commissioner of Inland 12 Fisheries and Wildlife will recommend any changes to the list of endangered and threatened species to the joint standing committee of the Legislature having jurisdiction over fisheries 14 wildlife matters. 16 These recommendations will help provide criteria on which the Legislature bases its decisions regarding the classification 18 of endangered and threatened species. 20 22 SPONSORED BY: (Representative 26 TOWN: East Millinocket
