SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to H.P. 536, L.D. 732, Bill, "An Act to Increase the Compensation of Members of the State Claims Commission"

Amend the amendment by striking out everything after the title and before the statement of fact and inserting in its place the following:

'Amend the bill in section 1 in subsection 5 in the first line (page 1, line 6 in L.D.) by striking out the following: "\$200" and inserting in its place the following: '\$150'

Further amend the bill in section 2 in the first paragraph in the last line (page 1, line 14 in L.D.) by striking out the following: "\$200" and inserting in its place the following: '\$150'

Further amend the bill by inserting after section 2 the following:

'Sec. 3. Allocation. The following funds are allocated from the Highway Fund to carry out the purposes of this Act.


