| 30 | Pursuant to rules adopted under this section, the commissioner may authorize the placement of logo signs within the |

| 34 | logo signs and must describe the procedure for applying to the department for permission to erect a logo sign and the criteria |

paragraphs B and C and logo signs erected pursuant to section
<u>1912-B</u>, may be located within the right-of-way limits of the interstate system or within 660 feet of the nearest edge of the
interstate system and erected in such a fashion that the message may be read from the interstate highway.

Sec. 3. Improvement of highway signing. The Department of Transportation shall review highway signing and develop a plan to make the State's highway signing easier to use. That plan must be implemented by the department as signs are replaced and as funding becomes available. In developing that plan, the department shall consider:

14 1. Including the distance in miles to towns on signs that indicate the direction to a town;

2. Including on directional signs the name and distance in 18 miles to known tourist destinations and towns along that route;

- 20 3. Placing signs indicating lane use over the road and respective lane; and
- 4. Improving signing to major points of interest to 24 tourists.
 - Sec. 4. Allocation. The following funds are allocated from Other Special Revenue to carry out the purposes of this Act.

This bill provides additional Other Special Revenue Transportation of \$5,000 8 allocations to the Department of 1995-96 annually beginning in fiscal year to authorize 10 expenditures for the logo signing program. The department is authorized to set fees to cover placement and maintenance costs. 12 The actual amounts of dedicated revenue and expenditures in this program may vary from the estimated amounts of \$5,000 annually. The amounts will depend on the demand for the signs and the rules 14 for placing the signs, which can not be determined at this time.

The additional costs to promulgate rules for logo signing 18 can be absorbed within the Department of Transportation utilizing existing budgeted resources.

The bill also directs the Department of Transportation to 22 review signing and develop a plan to make signs easier for public use. Implementation of this plan can be carried out utilizing 24 existing budgeted resources.'

STATEMENT OF FACT

This amendment replaces the bill. The amendment allows the Commissioner of Transportation to authorize the placement of logo signs within the right-of-way of the interstate system. Prior to authorizing any logo signs, the commissioner must adopt rules regulating the size, shape, manner and location of logo signs. The amendment also directs the commissioner to prepare a long-term plan for making the State's highway signs easier to use. The amendment also adds an allocation section and a fiscal note to the bill.
