## STATEMENT OF FACT

This amendment changes the membership of the State Poet Laureate Selection Advisory Panel by eliminating from the panel the chairs of the English departments of each of the campuses of the University of Maine System and replacing them with one of the University of representative Maine System, representative of private universities and colleges and one representative of public school English teachers. This amendment adds a provision requiring each panel member to survey the colleagues the member represents for the names of candidates to be considered by the full panel for recommendation to the This amendment also makes technical changes to the Governor. bill and adds a fiscal note.
