## **FISCAL NOTE**

This amendment clarifies that the revenue collected by the Department of Professional and Financial Regulation from the fees assessed on athletic trainers are dedicated to the licensure of athletic trainers. A new program is created within the department to segregate these fees from other dedicated revenues of the department.

## STATEMENT OF FACT

This amendment requires the Commissioner of Professional and Financial Regulation to prepare a budget relating to the licensure of athletic trainers. It also requires that fees and revenues received from the licensure of athletic trainers be placed in a separate, nonlapsing fund to pay for the cost of licensing athletic trainers.
