HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to H.P. 699, L.D. 957, Bill, "An Act to Require Licensure for Use of the Title Athletic Trainer"

Amend the amendment by inserting after the first paragraph after the title the following:

'Further amend the bill in section 1 in that part designated "\$14353." by inserting after subsection 7 the following:

'8. Budget. The commissioner shall prepare a budget in accordance with Title 5, section 1665 to carry out the purposes of this chapter.'

Further amend the amendment by inserting after the 2nd paragraph after the title the following:

'Further amend the bill in section 1 by inserting after that part designated "\$14361." the following:

'\$14362. Disposition of fees

All money received pursuant to this chapter must be paid to the Treasurer of State and credited to the athletic trainers account within the budget of the Division of Licensing and Enforcement.

Money credited to the athletic trainers account must be used for the expenses of administering its statutory responsibilities, including, but not limited to, the costs of conducting investigations, taking testimony and procuring the attendance of witnesses, the costs of all legal proceedings initiated for enforcement and administrative expenses.'

2 Further amend the amendment in section 3 in the 3rd line
(page 1, line 37 in amendment) by inserting after the following:
"Enforcement," the following: 'athletic trainers account'

6 Further amend the amendment in section 4 in that part
designated "PROFESSIONAL AND FINANCIAL REGULATION,
8 DEPARTMENT OF" by striking out the following: "Division of
Licensing and Enforcement" (page 2, lines 7 and 8 in amendment)
10 and inserting in its place the following: 'Division of Licensing
and Enforcement - Athletic Trainers'

14 **FISCAL NOTE**

16 This amendment clarifies that the revenue collected by the
Department of Professional and Financial Regulation from the fees
18 assessed on athletic trainers is dedicated to the licensure of
athletic trainers. A new account is created within the Division
20 of Licensing and Enforcement to segregate these fees from other
dedicated revenues of the department.

24 **STATEMENT OF FACT**

26 This amendment requires the Commissioner of Professional and
Financial Regulation to prepare a budget relating to the
licensure of athletic trainers. It also requires that fees and
28 revenues received from the licensure of athletic trainers be
placed in an athletic trainers account within the budget of the
30 Division of Licensing and Enforcement.
