HOUSE AMENDMENT "" to COMMITTEE AMENDMENT "A" to H.P. 699, L.D. Further amend the amendment in section 3 in the 3rd line 2 (page 1, line 37 in amendment) by inserting after the following: "Enforcement," the following: 'athletic trainers account' Further amend the amendment in section 4 in that part , 6 "PROFESSIONAL AND FINANCIAL REGULATION, designated DEPARTMENT OF" by striking out the following: "Division of 8 Licensing and Enforcement" (page 2, lines 7 and 8 in amendment) and inserting in its place the following: 'Division of Licensing 10 and Enforcement - Athletic Trainers' 12 **FISCAL NOTE** 14 This amendment clarifies that the revenue collected by the 16 Department of Professional and Financial Regulation from the fees assessed on athletic trainers is dedicated to the licensure of 18 athletic trainers. A new account is created within the Division of Licensing and Enforcement to segregate these fees from other 20 dedicated revenues of the department. 22 STATEMENT OF FACT 24 This amendment requires the Commissioner of Professional and Financial Regulation to prepare a budget relating to the 26 licensure of athletic trainers. It also requires that fees and 28 revenues received from the licensure of athletic trainers be placed in an athletic trainers account within the budget of the 30 Division of Licensing and Enforcement.
