COMMITTEE AMENDMENT "A" to H.P. 714, L.D. 971, Bill, "An Act to Require Special Care Program Disclosure by Entities Providing Alzheimer Care"

Amend the bill in section 1 in that part designated "~~§8551.~~" in subsection 1, in the 5th line (page 1, line 17 in L.D.) by inserting after the following: "individual" the following: 'to areas'

Further amend the bill in section 1 in that part designated "~~§8551.~~" in subsection 1, paragraph B, in the last line (page 1, line 26 in L.D.) by striking out the following: "or"

Further amend the bill in section 1 in that part designated "~~§8551.~~" in subsection 1, paragraph C; in the last line (page 1, line 29 in L.D.) by striking out the following: "1681." and inserting in its place the following: '1681; or'

Further amend the bill in section 1 in that part designated "~~§8551.~~" in subsection 1, by inserting at the end the following:

'D. Other facility, including, but not limited to, assisted living, adult daycare, congregate housing and eating and lodging facilities.'

Further amend the bill in section 1 in that part designated "~~§8552.~~" in subsection 1, in the 3rd line from the end (page 1, line 40 in L.D.) by inserting after the following: "program" the following: 'or the individual's guardian or other responsible party'

4 line 21 in L.D.) by striking out the following: "and"

6 Further amend the bill in section 1 in that part designated
"§8552." in subsection 2, paragraph H in the last line (page 2,
8 line 24 in L.D.) by striking out the following: "fees." and
inserting in its place the following: 'fees; and'

10 Further amend the bill in section 1 by inserting at the end
12 the following:

14 'I. A description of security measures provided by the
16 facility.'

18 Further amend the bill by inserting at the end before the
statement of fact the following:

20 **FISCAL NOTE**

22 The additional costs to review these disclosures as part of
the license renewal process can be absorbed by the Department of
24 Human Services utilizing existing budgeted resources.'

26 **STATEMENT OF FACT**

28 This amendment clarifies the limitations on access to areas
30 outside of Alzheimer's special care program areas. It expands
the type of entities meeting the definition of offering
32 Alzheimer's programs. It provides for disclosure of information
to guardians or other responsible parties. It adds to the
34 information that must be disclosed a description of security
measures. It also adds a fiscal note.
