20	Amend the amendment by striking out all of section 1 and inserting in its place the following:
22	Sec. 1. 24-A MRSA §3102-A is enacted to read:
24	§3102-A. Indemnification; surety on bonds
26	1. Annual notice to indemnitors. An insurer authorized to transact surety insurance in this State that acts as surety upon
28	a payment or performance bond executed in this State in reliance
30	<u>on an indemnity agreement shall annually notify the following persons of the existence of the indemnity agreement:</u>
32	A. All indemnitors who are residents of the State;
34	B, All indemnitors of a bond executed by a corporation incorporated in the State; and

38	C. The surety insurer's agent or broker, if an agent or broker is involved.
40	Notice to the indemnitors must be sent by certified mail to their last known address. The annual notice must be sent on or before

the anniversary of the date of the execution of the indemnity agreement.

2. Termination of indemnity agreement. Failure to send an 4 annual notice in accordance with the requirements of this section terminates an indemnity agreement executed after the effective 6 date of this section as to any indemnitor to whom the annual notice was not sent. In no event does failure to send an annual 8 notice or termination of the indemnity agreement relieve an indemnitor or the indemnitors' heirs, successors or assigns from 10 past, present or future liability arising under any such bond executed in reliance upon the indemnity agreement if that 12 indemnity agreement was in effect at the time the bond was 14 executed.

16 3. Notice when bonds are executed. The agent, broker or surety must provide a copy of the annual notice of the existence 18 of an indemnity agreement sent by the surety or a copy of the indemnity agreement to the person or persons executing the bond.' 20

STATEMENT OF FACT

24 This amendment, which incorporates the substance of House Amendment "A" to Committee Amendment "A", requires that 26 notification of indemnity agreements made in connection with 28 performance or payment bonds be made on an annual basis to 28 indemnitors who are residents of the State and who indemnify 29 bonds executed by corporations of this State. Notification must 30 also be made to an indemnitor who is a principal on the bond.
