The amendment replaces the language of the original bill. It amends the law concerning a mandatory suspension of a lobster and crab fishing license when a license holder is convicted of a 2nd or subsequent offense of possessing short lobsters and the 2nd offense involves 3 or more lobsters. It changes current law by requiring the first conviction to occur after July 1, 1994.
