STATEMENT OF FACT

2 Currently, the Office of Substance Abuse is developing 4 patient placement criteria to ensure uniform criteria for assessment and treatment of substance abuse problems. This bill 6 requires that all facilities who contract with the office adhere to these criteria after January 1, 1996. The Superintendent of 8 Insurance is required to assist in enforcing these criteria.
