	Be it enacted by the People of the State of Maine as follows:
2	Sec. 1. 5 MRSA §6211 is enacted to read:
4	<u>§6211. Land for Maine's Future Board-sponsored credit card</u>

8	1. Land for Maine's Future Board-sponsored credit card. The Land for Maine's Future Board may enter into an agreement with a financial institution, as defined in Title 9-B, section
10	131, subsection 17, or a credit union, as defined in Title 9-B, section 131, subsection 12, to issue a credit card for the
12	benefit of the Land for Maine's Future Board.
14	2. Agreement. If the Land for Maine's Future Board enters into an agreement with a financial institution or credit union in
16	accordance with subsection 1, the Land for Maine's Future Board shall negotiate the most favorable agreement for the Land for
18	Maine's Future Board, considering such factors as:
20	A. The rate for the Land for Maine's Future Board's fee by a credit card issuer;
22	D The chility of the financial inchibution to market the
24	B. The ability of the financial institution to market the card successfully; and
26	C. Customer service offered by the financial institution.
28	3. Distribution of proceeds. Funds received by the Land for Maine's Future Board under the agreement with the financial
