SENATE AMENDMENT " A " to COMMITTEE AMENDMENT "A" to H.P. 858, L.D. 1189, "Resolve, to Create a Task Force on Economic Development Tax Incentives"

Amend the amendment by inserting after the 5th indented paragraph on page 2 the following:

'Further amend the resolve in section 3 in the 7th line (page 2, line 21 in L.D.) by striking out the following: "July 15" and inserting in its place the following: 'August 15' '

Further amend the amendment by inserting after the 3rd indented paragraph on page 3 the following:

'Further amend the resolve section 7 in the 2nd line (page 3, line 19 in L.D.) by striking out the following: "2 public hearings" and inserting in its place the following: '1 public hearing' '

Further amend the amendment in the 7th indented paragraph in the last line (page 3, line 42 in amendment) by striking out the following: "January 15, 1996" and inserting in its place the following 'December 15, 1995'

Further amend the amendment by striking out all of section 10 and inserting in its place the following:

'Sec. 10. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
