10 Further amend the bill in section 1 in subsection 1-A in the 6th to 8th lines (page 1, lines 11 to 13 in L.D.) by striking out 12 the following: "review-by-the-joint-standing-committee-of-the Legislature-having-jurisdiction-over-marine-resources-and-te" and 14 inserting in its place the following: 'review by the joint standing committee of the Legislature having jurisdiction over 16 marine resources and to'

18 Further amend the bill by inserting after section 2 the following:

'Emergency clause. In view of the emergency cited in the 22 preamble, this Act takes effect when approved.'

Further amend the bill by relettering or renumbering any nonconsecutive Part letter or section number to read consecutively.

28 Further amend the bill by inserting at the end before the statement of fact the following:

**'FISCAL NOTE** 

34 The Department of Marine Resources will realize some minor savings from changes in the authorized compensation for members 36 of the Marine Resources Advisory Council.'

## STATEMENT OF FACT

The amendment changes compensation for members of the Marine 42 Resources Advisory Council from \$25 a day to payment of expenses only. It also keeps current statutory language requiring that 44 the Governor's appointments to the council be reviewed by the joint standing committee of the Legislature having jurisdiction 46 over marine resources.

48 It also adds a fiscal note and an emergency preamble and clause to the bill.
