This amendment will increase dedicated revenue from license fees. The Department of Public Safety will also incur additional costs to monitor the additional activity associated with this amendment. The revenue and costs are dependent on the number of organizations that will apply for and receive this new license option. Assuming one organization participates, this amendment will result in an increase in dedicated revenue of \$50,000 in fiscal year 1996-97 and require an Other Special Revenue allocation to the Department of Public Safety of \$35,360 for the resulting overtime.
