STATEMENT OF FACT

24 This amendment requires the Department of Economic and Community Development and the Finance Authority of Maine to 26 undertake a study of the effectiveness of business incentives and the public's return on its investment in each of these incentives. The Department of Economic and Community Development 28 and the Finance Authority of Maine are required to report back to before February 1996 with 30 the Legislature on or 16, recommendations for changes necessary to improve the effectiveness and return on investment for business financial 32 incentives. 34
