HOUSE AMENDMENT "A" to H.P. 1098, L.D. 1542, "Resolve, for Laying of the County Taxes and Authorizing Expenditures of Penobscot County for the Year 1995"

Amend the resolve in section 1 by striking out all of the 2nd line from the end (page 1, line 35 in L.D.) and inserting in its place the following: '\$4,967,481.80'

Further amend the resolve in section 2 in that part designated "12 - Sheriff" by striking out all of the 2nd line (page 3, line 15 in L.D.) and inserting in its place the following:

'Personal Services 620,491'

Further amend the resolve in section 2 in that part designated "30 - Program Grants" by striking out all of the last line (page 4, line 4 in L.D.)

Further amend the resolve in section 2 by striking out all of that part designated "34 - Shaw House" (page 4, line 6 in L.D.)

Further amend the resolve in section 2 by striking out all of the 2nd line from the end (page 4, line 31 in L.D.) and inserting in its place the following:

'TOTAL GENERAL FUND \$7,375,458'

Further amend the resolve in section 3 by striking out all of the 5th line (page 4, line 40 in L.D.) and inserting in its place the following:

'Total Appropriations \$7,375,458.00'

Further amend the resolve in section 3 by striking out all of the last line (page 5, line 1 in L.D.) and inserting in its place the following:

'Amount to be Raised by Taxation \$4,967,481.80'

FISCAL NOTE

This amendment reduces the amount of the county tax assessment by \$9,500. The increase in the county tax assessment for Penobscot County is reduced from \$120,344 to \$110,844.

STATEMENT OF FACT

This amendment makes the following changes to the budget for Penobscot County:

- 1. It eliminates a \$5,000 program grant for Millinocket Economic Development;
- 2. It eliminates \$2,500 for Shaw House; and
- 3. It decreases by \$2,000 the amount appropriated for personal services for the sheriff's department. This reduction is intended to decrease by \$2,000 the salary of the Penobscot County sheriff from the proposal submitted by the Penobscot County Commissioners.
