## STATEMENT OF FACT

This amendment creates a 17-member study commission to 40 investigate alternative methods of financing public education and different methods of reducing reliance on property taxes to fund 42 education. The commission must submit its report and any accompanying legislation to the First Regular Session of the 44 118th Legislature.
