An Act Regarding Timothy Harkins and Maine State Retirement System Benefits.

## Be it enacted by the People of the State of Maine as follows:

Sec. 1. Legislative findings. It is the finding of the Legislature that the circumstances surrounding the disability 4 retirement benefits paid to Timothy Harkins II are such that it 6 is not practicable to provide for their resolution by general law. It is further the finding of the Legislature that, Timothy Harkins II having received disability retirement benefits from 8 the Maine State Retirement System for 13 years, it is presumed that the benefits were properly calculated. It is also the 10 finding of the Legislature that Timothy Harkins II relied upon the Maine State Retirement System's calculations, and if these 12 calculations were in error, the Maine State Retirement System is precluded from changing the calculation of future benefits and 14 from requiring any reimbursement from Timothy Harkins II for past 16 benefits.

Sec. 2. Entitlement to disability retirement benefits; Maine State 18Retirement System payment. Notwithstanding the Maine Revised Statutes, Title 5, chapter 425, subchapter IV, article 3, or any 20 other contrary provision of law, Timothy Harkins II is entitled 22 to disability retirement benefits. The Maine State Retirement System shall provide to Timothy Harkins II disability retirement benefits as calculated by the Maine State Retirement System prior 24 1995 subject to February 1, to applicable cost-of-living adjustments, income offsets or other applicable administrative 26 adjustments so long as the disability on which those benefits was 28 based continues.

Sec. 3. Maine State Retirement System prohibited from seeking reimbursement. Notwithstanding the Maine Revised Statutes, Title
5, chapter 425, subchapter IV, article 3 or any other contrary provision of law, the Maine State Retirement System may not
require Timothy Harkins II to reimburse any overpayment of money received from the Maine State Retirement System that was in
excess of that authorized by law.

## STATEMENT OF FACT

This bill directs the Maine State Retirement System to 42 continue pay to Timothy Harkins II the level of disability retirement benefits it was paying on February 1, 1995 as long as 44 the disability continues. In view of the failure for 13 years of the Maine State Retirement System to recognize any potential 46 overpayment, it prohibits the Maine State Retirement System from seeking reimbursement of any overpayment from Timothy Harkins II.
