## An Act Authorizing the Town of Mount Vernon to Withdraw from the Cobbossee Watershed District.

Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26. Received by the Clerk of the House on December 6, 1995. Referred to the Committee on Utilities and Energy and ordered printed pursuant to Joint Rule 14.

#### Be it enacted by the People of the State of Maine as follows:

Sec. 1. P&SL 1971, c. 95, §1, as repealed and replaced by P&SL 1973, c. 189, §1, is amended to read:

Sec. 1. Territorial limits; name; purposes. 6 The territory and inhabitants therein for the Towns and Cities of Mount--Vernon, Readfield, Winthrop, Wayne, Monmouth, Manchester, Litchfield, 8 West Gardiner, Gardiner and Richmond are created a body corporate and politic under the name of "Cobbossee Watershed District" for 10 the purpose of protecting, improving and conserving the lakes, ponds and other waterways within the territory of said district 12 which comprise the Cobbossee watershed, so called, down to 100 feet below the New Mills dam, so called, all for the public 14 health and welfare and for the benefit of said residents and of 16 the property on, adjacent to or near said watershed, in the manner, with the rights, duties and immunities hereinafter in this Act set forth. 18

20 Sec. 2. P&SL 1971, c. 95, §3, 2nd ¶, first sentence is amended to read:

As soon as may be after the acceptance of this Act, as 24 hereinafter provided, the municipal officers of said 10 municipalities and the trustees of the Augusta Water District, Winthrop Water District and the Gardiner Water District shall 26 each appoint a trustee to hold office as follows: Those appointed by Readfield, Winthrop, Monmouth, Wayne and Manchester 28 shall be appointed for a 3-year term, those appointed by Litchfield, West Gardiner, Richmond, - Mount--Vernen and Gardiner 30 shall be appointed for a 2-year term and those appointed by said water districts shall be appointed for a one-year term. 32

Sec. 3. Effective date; referendum; certificate to Secretary of State. 34 Act takes effect 90 days after adjournment of the This Legislature only for the purpose of permitting its submission to 36 the legal voters of the Towns of Mount Vernon, Winthrop, Wayne, Readfield, Monmouth, Manchester, Litchfield, West Gardiner and 38 Richmond and the City of Gardiner at meetings called and held for Such meetings must be called, advertised and 40 the purpose. conducted according to the law relating to municipal elections; except that the registrars of voters are not required to prepare, 42 nor the clerks to post, a new list of voters, and for the purpose 44 of registration of voters said registrars of voters shall be in session on the secular day next preceding said meeting. The municipal clerks shall reduce the subject matter of this Act to 46 the following question:

The voters shall indicate by a cross or check mark placed against the word "Yes" or "No" their opinion of the same.

This Act takes effect for all purposes immediately upon 4 acceptance by a majority of the municipalities voting at said meetings; but only if the total number of votes cast for and 6 against the acceptance of this Act at any meeting of that majority of the municipalities equaled or exceeded 15% of the 8 total vote for all candidates for Governor cast in said town at the next preceding gubernatorial election, but failure of 10 approval of such meetings does not prevent a subsequent meeting or meetings to be held for said purpose. The result of the votes 12 must be declared by the municipal officers of the town or city and due certificate of the vote must be filed by the clerk with 14 the Secretary of State.
