22	Amend the bill in section 1 in that part designated " $\S900-H$." by striking out all of subsection 1 and inserting in
24	its place the following:
26	' 1. Membership. The budget committee consists of 15 members as follows:
28	A. Three members elected from each commissioner district as
30	provided in subsection 2;
32	B. One municipal official appointed by each county commissioner from the commissioner's district; and
34	C. Three members of the county legislative delegation

38	Further amend the bill in section 1 by striking out all of that part designated " §900-1. " and inserting in its place the

44	1. Public hearing. The Penobscot County commissioners shall hold one or more public hearings on the budget at times

the budget committee no later than November 1st of each year. 2 The budget committee shall review the budget and make additions or deletions to the budget by a majority vote of the committee. 4 The budget must be presented to the county commissioners by December 1st of each year. The county commissioners shall act on б the budget no later than December 15th of the year preceding the budget year, If the adopted budget is changed by the county commissioners, the budget committee may reject that change by a 8 2/3 vote of its membership no later than December 31st of that 10 year. Those actions are final and not subject to further action by either the county commissioners or the budget committee. 12 3. Budget presentation to legislative delegation. Before

14 December 15th annually, the county commissioners, in conjunction with the budget committee, shall present the proposed budget to 16 the Penobscot County legislative delegation at a meeting called by the chair of the legislative delegation for that purpose. 18 Copies of the proposed budget must be submitted to the chair of the legislative delegation at least 7 days prior to the meeting. 20

4. Assessment of taxes. The budget adopted under 22 subsection 2 is the final authorization for the assessment of county taxes. The county tax authorized is apportioned and 24 collected in accordance with section 706.

5. Final budget: filing. A copy of the final budget must
 be filed on forms approved by the Department of Audit with the
 State Auditor, who shall retain them for 3 years.

30 6. Interim budget. If the budget is not approved before the start of the fiscal year, the county must operate on an 32 interim budget that does not exceed the budget of the previous year until a final budget is adopted.'

48 The establishment of the Penobscot County Budget Committee represents a state mandate pursuant to the Constitution of 50 Maine. The additional local costs associated with the budget

committee including additional advertising, postage and printing costs are expected to be minor. General Fund appropriations will be required to fund at least 90% of the additional costs.'

STATEMENT OF FACT

This amendment amends the bill to accomplish the following:

Change the selection process for the county legislative delegation members of the budget committee so that they are chosen by the county delegation;

 Require the county commissioners and budget committee to explain the proposed county budget to the legislative delegation at a meeting called by the chair of the legislative delegation;

18 3. Change the vote needed for the budget committee to override changes made by the county commissioners in the budget 20 committee's recommended budget from 4/5 of the committee's membership to 2/3;

4. Clarifies that the budget as finalized by the county 24 commissioners and budget committee is the authorization for the assessment of county taxes;

5. Repeals the budget committee on December 31, 1999; and
6. Adds a fiscal note.
