An Act to Improve Tribal and State Relations by Strengthening the Maine Indian Tribal-State Commission.

Approved for introduction by a majority of the Legislative Council pursuant to Joint Rule 26. Reference to the Committee on Judiciary suggested and ordered printed.

Sec. 1. 30 MRSA §6212, sub-§§1 to 3, as amended by PL 1993, c. 600, Pt. A, §24 and affected by §25, are further amended to read:

- Commission created. 1. The Maine Indian Tribal-State Commission is established. The commission consists of 9  $\underline{13}$ members, 4 to be appointed by the Governor, subject to review by the Joint Standing Committee on Judiciary and to confirmation by the Legislature, 2 to be appointed by the Passamaquoddy Tribe, 2 by the Penobscot Nation, the 2 Tribal appointed Representatives to the Legislature, a member of the state House of Representatives to be appointed by the Speaker of the House, a member of the Senate to be appointed by the President of the Senate and a chair, to be selected in accordance with subsection The members of the commission, other than the Tribal Representatives to the Legislature, the 2 State Legislators and the chair, each serve for a term of 3 years and may be reappointed. The Tribal Representatives to the Legislature and the 2 Legislators serve concurrently with their legislative terms. In the event of the death, resignation or disability of a member, the appointing authority may fill the vacancy for the unexpired term.
- 2. Chair. The commission, by a majority vote of its 8 12 other members, shall select an individual who is a resident of the State to act as chair. When 8 12 members of the commission by majority vote are unable to select a chair within 120 days of the first meeting of the commission, the Governor, consulting with the governors of the Penobscot Nation and the Passamaquoddy Tribe, shall appoint an interim chair for a period of one year or for the period until the commission selects a chair in accordance with this section, whichever is shorter. In the event of the death, resignation or disability of the chair, the commission may select, by a majority vote of its 8 12 remaining members, a new chair. When the commission is unable to select a chair within 120 days of the death, resignation or disability, the Governor, after consulting with the governors of the Penobscot Nation and the Passamaquoddy Tribe, shall appoint an interim chair for a period of one year or for the period until the commission selects a chair in accordance with this section, whichever is shorter. The chair is a full-voting member of the commission and, except when appointed for an interim term, shall serve for 4 years.
- 3. Responsibilities. In addition to the responsibilities set forth in this Act, the commission shall continually review the effectiveness of this Act and the social, economic and legal

relationship between the Passamaquoddy Tribe and the Penobscot

Nation and the State and shall make such reports and
recommendations to the Legislature, the Passamaquoddy Tribe and
the Penobscot Nation as it determines appropriate.

Seven members constitute a quorum of the commission and a decision or action of the commission is not valid unless 5  $\frac{7}{8}$  members vote in favor of the action or decision.

Sec. 2. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Act.

Sec. 3. Effective date; certification. Section 1 of this Act does not take effect unless, within 60 days of the adjournment of the Secretary State receives Legislature, the of certification by the Governor and the Council of the Penobscot Nation and the Joint Tribal Council of the Passamaquoddy Tribe that the nation and the tribe have agreed to the provisions of this Act pursuant to 25 United States Code, Section 1725(e), copies of which must be submitted by the Secretary of State to the Secretary of the Senate, Clerk of the House Representatives and the Revisor of Statutes; except that in no event may this Act become effective until 90 days after the adjournment of the Legislature.
