An Act Allowing Towns to Form Regional Shellfish Management Committees.

Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 12 MRSA §6671, sub-§2, as amended by PL 1983, c. 838, 4 $\S2$, is further amended to read: 2. Municipal program and ordinance. Any municipality may, 6 by vote of its legislative body, adopt, amend or repeal a shellfish conservation ordinance regulating the possession of 8 shellfish in any area of the municipality as provided by this 10 section. A municipal shellfish management committee comprised of residents of that municipality may be established to administer a 12 municipal program. 14 Sec. 2. 12 MRSA §6671, sub-§3-A, ¶F, as enacted by PL 1989, c. 257, \S and 5, is amended to read: 16 F. When 2 or more municipalities have entered into an agreement-with-one-another-for-joint-or-cooperative-action 18 under--this--subsection a regional shellfish management 20 agreement pursuant to subsection 7, the combined total number of commercial licenses for nonresidents provided by those municipalities shall must be a number not less than 22 10% of the combined total number of commercial licenses 24 issued for residents. When the combined total number of resident commercial licenses is fewer than 10 but more than 5, at least one nonresident commercial license shall must be 26 When the combined total number of resident provided. commercial licenses is 5 or fewer, nonresident commercial 28 licenses shall are not be required. 30 Sec. 3. 12 MRSA §6671, sub-§7, as enacted by PL 1977, c. 661, 32 §5, is amended to read: Joint programs; reciprocal privileges. 34 7. Municipalities may enter into joint-conservation regional shellfish management agreements with other municipalities and adopt jeint regional 36 shellfish management programs. The agreements, and the programs and ordinances adopted under them, shall-be are subject to the 38 same requirements as municipal programs and ordinances. Resident privileges of one municipality in a joint regional shellfish 40 management agreement may be extended to the residents of other 42 municipalities in the agreement. Notwithstanding subsection 2, a regional shellfish management committee comprised of at least one resident from each municipality named in the regional agreement 44 may be established to administer a regional program. 46

STATEMENT OF FACT

2 This bill clarifies that a shellfish management agreement 4 between 2 or more municipalities may be administered by a regional shellfish conservation committee comprised of residents 6 of the towns in the agreement.
