COMMITTEE AMENDMENT "H" to H.P. 1269, L.D. 1744 2 Further amend the bill by relettering or renumbering any letter or section number to read nonconsecutive Part 4 consecutively. Further amend the bill by inserting at the end before the 6 statement of fact the following: 8 **'FISCAL NOTE** 10 1996-97 12 **APPROPRIATIONS/ALLOCATIONS** 14 \$250,000 16 Other Funds 18 REVENUES \$250,000 20 Other Funds Authorizing nonemergency state activations by the Maine National Guard will require additional Other Special Revenue 22 allocations of \$250,000 in fiscal year 1996-97 to authorize the 24 expenditure of funds paid to the Department of Defense and Veterans' Services as reimbursement for services provided by the 26 Maine National Guard. These allocations are based on currently anticipated activations during fiscal year 1996-97.' 28 30 STATEMENT OF FACT 32 This amendment removes the bill's emergency preamble and 34 emergency clause. 36 The amendment also retains existing language allowing a Justice of the Supreme Judicial Court, a Justice of the Superior Court, a county sheriff and certain local officials to request 38 assistance from the state military forces under certain 40 circumstances. 42 The amendment also strikes language in the bill that would have allowed the Adjutant General and the Deputy Adjutant General to order a member of the Maine National Guard, with the member's 44 consent, to perform active state service and to order into active state service necessary personnel and equipment of the Maine 46 This amendment grants that authority to the National Guard. 48 Governor or the Governor's designee. 50 The amendment also adds an allocation section and a fiscal note to the bill.
