The amendment provides a General Fund appropriation of \$12,750 in fiscal year 1996-97 for the Department of Education. The one-time printing, postage and meeting costs incurred by the school administrative units, estimated to average approximately \$50 per unit, will be paid from this appropriation by the Department of Education in accordance with the distribution schedule.

The amendment replaces the bill. The amendment changes the bill to a resolve that directs each school administrative unit to review the principles of education reform set forth in the report of the Task Force on Learning Results and to provide the Commissioner of Education a report on the projected program changes and the costs associated with implementation of those changes. The Commissioner of Education is directed to compile the reports and prepare a review and analysis, accompanied by any necessary implementing legislation, for submission to the Legislature by December 30, 1997. The amendment adds an appropriation section and a fiscal note to the bill.
