place the following: 4 '5. Refusal to submit animal for examination. An owner or 6 trainer may not refuse to secure or restrain an animal for examination by a licensed veterinarian or a technician or agent of the licensed veterinarian and may not interfere with the 8 restraining or securing of an animal for that examination.' 10 Further amend the bill in section 2 in that part designated "<u>§74-A.</u>" in subsection 8 in the 6th line (page 3, line 1 in L.D.) 12 by striking out the following: "the Maine Revised Statutes" 14 Further amend the bill in section 2 in that part designated "<u>§74-A.</u>" by striking out all of subsection 10 and inserting in 16 its place the following: 18 '10. Therapeutic drugs. This section does not prohibit the 20 administration to an animal of a drug, the use of which is required for treatment of an illness or condition unrelated to 22 the performance of the animal in the event. An animal in an event that receives a medication that contains a prohibited substance is not eligible for the event, unless the following 24 requirements have been met and the facts requested are submitted 26 in writing to the manager of the event. A. The medication must be therapeutic and necessary for 28 treatment of an illness or injury. 30 B. The animal must be withdrawn from the event for a period of at least 24 hours after medication has been administered. 32 34 C. Only a licensed veterinarian or a trainer acting under the direction of the licensed veterinarian may administer medication. The trainer may administer medication under the 36 direction of the licensed veterinarian if the licensed 38 veterinarian has assumed responsibility for making medical judgements regarding the health of the animal, has sufficient knowledge of the animal to make a general or 40 preliminary diagnosis of the animal and is readily available 42 to care for the animal in the event of an adverse reaction to medication or the failure of a trainer to adhere to a 44 therapy regimen. The amount, strength and mode of administration of 46 D.\_\_\_ medication must be identified. 48 E. The statement must include the date and time of the administration of medication. 50

The statement must be filed with the general manager of 12 the event within one hour after administration of medication or one hour after the manager of the event returns to duty, 14 if administration is at a time other than during event hours. 16 J. competing in livestock exhibitions. These costs can be absorbed within the department's existing budgeted resources.

4 This bill may increase the number of civil cases filed in the court system. The additional workload and administrative 6 costs associated with the minimal number of new cases filed can be absorbed within the budgeted resources of the Judicial 8 Department. The collection of additional fines may also increase General Fund revenue by minor amounts.'

## STATEMENT OF FACT

14 This amendment adds to the definition of "prohibited substance" any substance that the Commissioner of Agriculture,
16 Food and Rural Resources by rule determines could affect the conduct, actions, endurance, strength, speed performance,
18 appearance or disposition of an animal entering into a pulling event or livestock exhibition.

It also clarifies that an animal's owner or trainer may not 22 refuse to secure or restrain an animal for examination and may not interfere with the securing or restraining of an animal.

The amendment also requires notice to be provided to the 26 manager of an event when an animal has been administered a therapeutic drug. It also describes the conditions under which a 28 trainer may administer therapeutic drugs.

The amendment also adds a fiscal note to the bill.
