COMMITTEE AMENDMENT "A" to S.P. 716, L.D. 1817, Bill, "An Act to Provide a Contingent Allocation to Establish a Federally Funded Military Rebuild Site to be Operated by the Maine National Guard at the former Loring Air Force Base"

Amend the bill in section 1 under the caption "DEFENSE AND VETERANS' SERVICES, DEPARTMENT OF" in that part relating to "Loring Rebuild Facility" by striking out all of the 2nd and 3rd lines (page 1, lines 41 and 42 in L.D.) and inserting in their place the following:

Table with 3 columns: Description, Amount 1, Amount 2. Rows: 'Positions - Other Count (41.0) (41.0), Personal Services \$359,139 \$1,684,979'

Further amend the bill in section 1 under the caption "DEFENSE AND VETERANS' SERVICES, DEPARTMENT OF" in that part relating to "Loring Rebuild Facility" by striking out all of the last line (page 2, line 24 in L.D.) and inserting in its place the following:

Table with 3 columns: Description, Amount 1, Amount 2. Row: 'TOTAL \$709,139 \$2,034,979'

Further amend the bill by inserting at the end before the statement of fact the following:

This bill includes Federal Expenditure Fund allocations of \$709,139 and \$2,034,979 in fiscal year 1995-96 and fiscal year 1996-97, respectively, for the Loring Rebuild Facility program within the Department of Defense and Veterans' Services. These allocations are based on the projected costs of establishing a federally funded depot-level military rebuild site at the former Loring Air Force Base.

The Maine National Guard has applied for a federal grant through the United States Department of Defense that would fully fund these projected costs. The expenditures authorized by these allocations are contingent on receipt of these federal funds.'
