6	5. Silver Star medal recipients; special license plates. The Secretary of State, on application and upon evidence of
8	payment of the excise tax required by Title 36, section 1482, the registration fee required by section 501 and a one-time additional fee of \$10, shall issue to a person who is a Silver

The Secretary of State shall begin issuing Silver Star plates in accordance with this subsection no later than November 1, 1998.

6. Bronze Star medal recipients; special license plates.
The Secretary of State, on application and upon evidence of payment of the excise tax required by Title 36, section 1482, the registration fee required by section 501 and a one-time additional fee of \$10, shall issue to a person who is a Bronze Star medal recipient a registration certificate and a set of Bronze Star registration plates to be used in lieu of regular registration plates. The one-time additional fee of \$10 is credited to the Highway Fund for administrative and production costs.

An application for Bronze Star plates must be accompanied by proof that the applicant has been awarded the Bronze Star medal. The Secretary of State shall verify the documentation presented by the applicant. Misrepresentation of documents is in violation of section 2103, subsection 5.

The Secretary of State shall determine the design of the Bronze Star plate. Upon request and as provided by section 453, the Secretary of State shall issue Bronze Star plates that are also vanity plates. Bronze Star vanity plates are issued in accordance with this section and section 453. The annual service fee of \$15 for vanity plates is credited to the Highway Fund.

A Bronze Star recipient, or the surviving spouse of a Bronze Star recipient, who does not operate a motor vehicle or register a motor vehicle and who otherwise qualifies for the issuance of special Bronze Star registration plates may apply to the Secretary of State for a special single plate recognizing that award. The Secretary of State shall design and identify these single plates for recognition purposes only. Single Bronze Star plates may not be attached to a motor vehicle. Only one plate may be issued to each recipient and a one-time fee of \$5 charged.

The Secretary of State shall begin issuing Bronze Star plates in accordance with this subsection no later than July 1, 1999.

This bill authorizes the Secretary of State to issue special plates for recipients of the Silver Star medal and the Bronze Star medal.
