2 Reducing the meal allowance and increasing the constituent service allowance for legislators will result in net savings to the Legislature of \$57,620 in fiscal year 1998-99. This amount 4 is deappropriated. 6 In the 2000-2001 and subsequent biennia, this bill will 8 result in net savings of approximately \$31,000 over each biennium. Additional costs of approximately \$70,500 in fiscal year 1999-2000 and other fiscal years that coincide with 2nd 10 Regular Sessions will be offset by savings of approximately

18 The original bill reduced the meal allowance for Legislators from \$32 to \$16. This amendment reduces the meal allowance for 20 Legislators from \$32 to \$22 and transfers most of the savings realized by reducing the meal allowance to the constituent service allowance. The amendment adds an effective date of January 1, 1999. It also adds an appropriation section and a 24 fiscal note to the bill.
