SENATE AMENDMENT "A" to COMMITTEE AMENDMENT "A" to H.P. 60, L.D. 85, Bill, "An Act to Authorize a General Fund Bond Issue in the Amount of \$8,000,000 for Reconstruction, Renovations and Safety Improvements at the Governor Baxter School for the Deaf"

Amend the amendment by striking out the substitute title and replacing it with the following:

'An Act to Authorize a General Fund Bond Issue in the Amount of \$2,000,000 for Reconstruction, Renovations and Safety Improvements at the Governor Baxter School for the Deaf'

Further amend the amendment in the 2nd indented paragraph after the title in the last line (page 1, line 33 in amendment) by striking out the following: "\$3,000,000" and inserting in its place the following: '\$2,000,000'

Further amend the amendment in the 3rd indented paragraph after the title in the last line (page 1, line 37 in amendment) by striking out the following: "\$3,000,000" and inserting in its place the following: '\$2,000,000'

Further amend the amendment in the 4th indented paragraph after the title in the last line (page 1, line 42 in amendment) by striking out the following: "\$3,000,000" and inserting in its place the following: '\$2,000,000'

Further amend the amendment by striking out all of the fiscal note and inserting in its place the following:

FISCAL NOTE

The estimated cost of sending this bond issue out to referendum will vary according to the total number of referenda

2 enacted during the First Special Session of the 118th Legislature
3 to be submitted to the voters in November. The estimated cost to
4 the Secretary of State if one to 6 referenda are enacted is
\$95,000. Each additional referendum costs an additional \$7,000.

6 If approved by the voters, the total cost of this bond issue
7 is estimated to be \$2,282,000 with principal payments of
8 \$2,000,000 and interest payments of approximately \$282,000.'



13 This amendment reduces the bond amount to \$2,000,000 for

16 replaces the fiscal note.
