Further amend the bill in section 2, in subsection 3 in the 2nd line (page 1, line 16 in L.D.) by striking out the following: "," and inserting in its place the following: 'r' and in the 4th and 5th lines (page 1, lines 18 and 19 in L.D.) by striking out the following: "~~for calendar year 1996 or later~~ after October 1, 1997" and inserting in its place the following: 'for calendar year 1996 or later 1998 and thereafter'
