HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to S.P. 80, L.D. 219, "Resolve, to Establish Qualifications for Constitutional Officers"

Amend the amendment by striking out all of the 2nd and 3rd paragraphs after the title (page 1, lines 28 to 38 in amendment)

Further amend the amendment in section 6 in the last line (page 2, line 11 in amendment) by inserting after the following: "commission" the following: ', except for per diem and expenses paid to legislative members pursuant to section 7 of this resolve'

Further amend the amendment by striking all of section 7 (page 2, lines 13 and 14 in amendment) and inserting in its place the following:

'Sec. 7. Compensation. Resolved: That the legislative members of the commission are entitled to per diem and expenses upon application to the Executive Director of the Legislative Council. Other members are not entitled to compensation; and be it further'

Further amend the amendment on page 2 by inserting after the 4th indented paragraph the following:

'Further amend the resolve by inserting after section 8 the following:

'Sec. 9. Appropriation. Resolved: That the following funds are appropriated from the General Fund to carry out the purposes of this resolve.
