30	toll station on the southbound side of the Maine Turnpike <u>for the</u> state <u>discount liquor store</u> in <u>Kittery and the Department of</u>
32	Transportation shall erect and maintain guideposts at appropriate locations on Route 1 and Route 9 for the state discount liquor
34	store in Calais. The guidepost shall for the Kittery store must be worded as follows:
36	DISCOUNT LIQUOR STORE KITTERY
38	YORK EXIT U.S. ROUTE 1 SOUTH
40	The guideposts on Route 1 and Route 9 for the Calais store must be worded as follows:
