HOUSE AMENDMENT "H" to COMMITTEE AMENDMENT "A" to H.P. 283,
L.D. 347, Bill, "An Act to Require Overtime Pay for Employees of Large Agricultural Employers"

Amend the amendment by striking out all of section 1 (page 20 1, lines 26 to 40 in amendment) and inserting in its place the following:

'Sec. 1. 26 MRSA §664, sub-§3, as amended by PL 1995, c. 510, 24 §1, is further amended to read:

26 3. Overtime rate. An employer may not require an employee to work more than 40 hours in any one week unless 1 1/2 times the regular hourly rate is paid for all hours actually worked in 28 excess of 40 hours in that week. The regular hourly rate commissions 30 includes all earnings, bonuses, and other compensation that is paid or due based on actual work performed and does not include any sums excluded from the definition of 32 "regular rate" under the Fair Labor Standards Act, 29 United States Code, Section 207(e). 34

36 The overtime provision of this section does not apply to:

- A. Automobile mechanics, automobile parts clerks and automobile salesmen as defined in section 663;

  - C. Mariners;
- D. Public employees;
