An Act to Amend the Laws Regarding Snowmobile Registration.

Be it enacted by the People of the State of Maine as follows: 2 Sec. 1. 12 MRSA §7821, sub-§1-A is enacted to read: 4 1-A. Antique snowmobile. "Antique snowmobile" means a snowmobile more than 25 years old that is primarily used for б exhibition, parades and other events of interest to the public and not primarily used for recreational or commercial purposes. 8 Sec. 2. 12 MRSA §7824, sub-§2, as amended by PL 1995, c. 467, 10 \$3, is further amended to read: 12 The--annual--snowmobile--registration-fee--is--as Fee. 2. fellews A one-time registration fee for an antique snowmobile is 14 \$30. The registration for an antique snowmobile is valid for the life of the snowmobile. The annual registration fee for all 16 other snowmobiles is: 18 For residents, \$20. The registration for a snowmobile Α. owned by a resident is valid for one year, commencing on 20 July 1st of each year; and 22 B. For nonresidents: 24 (1)Thirty-five dollars for a 3-consecutive dav A person may purchase more than one registration. 26 3-day registration in any season; 28 Fifty dollars (2) for а 10-consecutive day registration. A person may purchase more than one 30 10-day registration in any season; and 32 Sixty dollars for a seasonal registration. (3) 34 The registration for a snowmobile owned by a nonresident 36 must specify the dates for which the registration is valid. Sec. 3. 12 MRSA §7824, sub-§8, ¶A-1 is enacted to read: 38 A-1. A person may transfer the ownership of an antique 40 snowmobile to another person upon payment of a transfer fee 42 of \$10. This transfer fee is paid in lieu of the regular registration fee for an antique snowmobile. 44 Sec. 4. 12 MRSA §7824, sub-§9, as amended by PL 1995, c. 467, $\S8$, is further amended to read: 46 9. Reciprocity. Except as specifically provided in this 48 subsection, and notwithstanding any other provision of law, a snowmobile may be possessed or operated by any person in this 50 State without being registered in this State as long as:

A. The snowmobile is properly registered in the name of a nonresident owner of the snowmobile;

B. The nonresident owner of the snowmobile is a resident of a state, province, country or district with which this State has reciprocity.

For purposes of this subsection, "state, province, country or district with which this State has reciprocity" means a state, 10 province, country or district that shares a common border with 12 this State and that offers similar privileges to residents of this State. A state, province, country or district does not offer similar privileges if Maine residents holding a valid Maine 14 snowmobile registration are charged a fee for access to the trail system in that state, province, country or district, or if, as 16 determined by the commissioner, privileges and opportunities offered to snowmobile users in that state, province, country or 1.8 district are not otherwise comparable to those offered in this 20 State.

A snowmobile owned by a nonresident may not be issued a resident 22 registration. Nothing in this subsection authorizes the operation of any snowmobile in any manner contrary to 24 this subchapter.

Sec. 5. 12 MRSA §7824, sub-§10, ¶B, as enacted by PL 1979, c. 420, \$1, is amended to read:

The registration number assigned to a snowmobile shall Β. displayed in such form and manner the must be as determine, except that an antique commissioner may snowmobile is not required to display registration numbers.

SUMMARY

This bill defines an antique snowmobile as a snowmobile more than 25 years old that is primarily used in exhibition, parades 38 and other events of interest to the public and not used primarily for recreational or commercial purposes. 40

The bill creates a one-time registration fee of \$30 42 for and allows that antique snowmobiles registration to be transferred to a new owner for a transfer fee of \$10. 44

The bill exempts owners of antique snowmobiles from the 46 requirement that they display their registration numbers on their snowmobile and restricts the reciprocity provisions of law 48pertaining to snowmobiles to states, provinces and countries sharing a common border with Maine. 50
