- Sec. 1. Commission established. Resolved: That the Commission on Tax Implications for Municipalities, referred to in this resolve as the "commission," is established to study the effects on municipalities of the repeal of the uniform property tax; and be it further
- Sec. 2. Commission membership. Resolved: That the commission consists of the following 5 members:
- 10 1. One member of the Maine Municipal Association, appointed by the Governor;

2. One representative of the Bureau of Taxation, appointed 14 by the State Tax Assessor;

Appointments; Sec. 3. meetings. **Resolved**: That all appointments must be made no later than 30 days following the 26 effective date of this resolve. The Executive Director of the 28 Legislative Council must be notified by all appointing authorities once the selections have been made. Within 15 days of appointment of all members, the Chair of the Legislative 30 shall call and convene the first meeting of Council the The commission shall select a chair from among its 32 commission. members: and be it further

- Sec. 4. Duties. Resolved: That the commission shall study the effects on municipalities of the repeal of the uniform property tax; and be it further
- Sec. 5. Staff assistance. Resolved: That the commission may 40 request staff assistance from the Legislative Council; and be it further
- Sec. 6. Reimbursement. Resolved: That the members of the commission shall serve without compensation or reimbursement of any type; and be it further
- Sec. 7. Report. Resolved: That the commission shall submit its report, together with any necessary implementing legislation, to the Second Regular Session of the 118th Legislature no later than December 31, 1997. If the commission requires an
