HOUSE AMENDMENT "B" to COMMITTEE AMENDMENT "A" to H.P. 390, L.D. 535, Bill, "An Act to Ban Partial Birth Abortions"

18 Amend the amendment in the 3rd indented paragraph after the title by striking out the first 2 lines (page 1, lines 31 and 32 in amendment) and inserting in their place the following:

'Sec. 1. 22 MRSA §1596, sub-§2, as repealed and replaced by PL 1989, c. 274, §1, is amended to read:

 Abortion reports. A report of each abortion performed
shall <u>must</u> be made to the Department of Human Services on forms prescribed by the department. These report forms shall <u>may</u> not
identify the patient by name or otherwise and shall <u>must</u> contain enly the information requested on the United States Standard
Report of Induced Termination of Pregnancy, published by the National Center for Health Statistics, dated January 1978, or any more recent revision of a standard report form, as well as the type of abortion procedure used.

The form containing that information and data shall <u>must</u> be 36 prepared and signed by the attending physician and transmitted to the department not later than 10 days following the end of the 38 month in which the abortion is performed.

A physician who reports data on an abortion pursuant to this section shall-be is immune from any criminal liability for that
abortion under section 1598.

'Sec. 3. 22 MRSA §1598, sub-§2, ¶A, as enacted by PL 1979, c. 405, §2, is amended to read:'

## **FISCAL NOTE**

This amendment adds a reporting requirement. The Department of Human Services will incur some minor additional costs to revise forms for required abortion reporting and to process the 14 additional information included in these abortion reports. These costs can be absorbed within the department's existing budgeted 16 resources.

**SUMMARY** 

22 This amendment requires physicians who perform abortions to report the abortions procedure used when reporting abortions information to the Department of Human Services. 24 This will result in better data for abortions in this State.
