An Act to Create a Toll-free Number for Regional Unemployment Offices.

## Be it enacted by the People of the State of Maine as follows:

Sec. 1. 26 MRSA §1082, sub-§1, as amended by PL 1995, c. 560, Pt. G, §11, is further amended to read:

1. Powers and duties of the commissioner. Except as 6 otherwise provided, it is the duty of the Commissioner of Labor to administer this chapter, through an organization to be known 8 as the Bureau of Unemployment Compensation. The commissioner may expenditures, require 10 employ persons, make reports, make investigations and take other actions the commissioner determines 12 necessary or suitable to that end. The commissioner is responsible and possesses the necessary authority for the 14management operation and of the Bureau of Unemployment The commissioner shall determine methods of Compensation. 16 operational procedures in accordance with the provisions of this chapter. The commissioner may adopt rules in accordance with the Maine Administrative Procedure Act, Title 5, chapter 375, to 18 achieve this purpose, except rules pertaining to unemployment insurance as provided in subsection 2. The commissioner may 20 adopt rules with respect to a self-employment assistance program 22 as provided in section 1197. The commissioner shall determine methods of operational procedures in accordance with the provisions of this chapter and by the Maine Administrative 24 Procedure Act, Title 5, chapter 375. The commissioner shall make 26 recommendations for amendments to this chapter that the commissioner determines proper. When the commissioner believes 28 that a change in contribution or benefit rates is necessary to protect the solvency of the fund, the commissioner shall promptly inform the Governor and the Legislature and make recommendations 30 with respect to the change in rates. The commissioner shall 32 establish a toll-free telephone number to connect claimants and employers to the appropriate local unemployment office. 34

## SUMMARY

38 This bill requires the Commissioner of Labor to set up a toll-free telephone number so that individuals and employers may transact business with the appropriate unemployment office without having to make a long-distance telephone call.
