| 20 | 'Sec. 2. Statutory referendum procedure; submission at general election; form of question; effective date. This Act must be submitted |
| 22 | to the legal voters of the State of Maine at the next general election in the month of November following passage of this Act. |
| 24 | The municipal officers of this State shall notify the inhabitants of their respective cities, towns and plantations to meet, in the |
| 26 | manner prescribed by law for holding a statewide election, to vote on the acceptance or rejection of this Act by voting on the |

| 30 | "Do you favor giving competent, terminally ill adult patients the right to choose a physician's aid in dying?" |

HOUSE AMENDMENT "H" to H.P. 663, L.D. 916

FISCAL NOTE

The estimated cost of sending this Act out to referendum will vary according to the total number of referenda enacted during the Second Regular Session of the 118th Legislature to be submitted to the voters in November. The estimated cost to the Secretary of State if one to 6 referenda are enacted is \$95,000. Each additional referendum costs an additional \$7,000.

SUMMARY

This amendment makes the bill contingent upon the approval of the voters at the next general election.
