This bill has no effect on state revenue or expenditures.' 12 14 **SUMMARY** 16 This amendment expands the types of entities that the Finance Authority of Maine may contract with to issue a credit 18 card to benefit the Scholarships for Maine Fund to include credit card issuers. 20 The amendment also adds a fiscal note to the bill.
