Sec. 4. 29-A MRSA §1605, sub-§8 is enacted to read:

 8. Electronic filing of proof of financial responsibility. The Secretary of State shall implement a system for the electronic filing of proof of financial responsibility under this section.'

Further amend the bill by inserting at the end before the 16 summary the following:

FISCAL NOTE

The additional costs associated with implementing a system 22 for the electronic filing of proof of financial responsibility can be absorbed by the Bureau of Motor Vehicles within the 24 Department of the Secretary of State utilizing existing budgeted resources.'

SUMMARY

30 The amendment requires any person who violates the vehicle liability insurance and financial responsibility laws to provide the Secretary of State proof of financial responsibility. It also amends the bill by requiring that a system for the electronic filing of vehicle insurance apply only to people who violate the vehicle insurance laws. The bill proposed that the system apply to all people with registered vehicles. It also adds a fiscal note to the bill.
