 Examine laws from other states relating to the registration of personal care and support workers providing services in homes, assisted living centers, residential care
facilities and supported living facilities;

 Examine registration, recording and reporting systems for personal background information and criminal record checks
of personal care and support workers working in homes, assisted living centers, residential care facilities and supported living
facilities;

 Evaluate different registration, recording and reporting systems, including, but not limited to, the impact on consumer choice and consideration of timeliness and cost for consumers, persons providing care, agencies or entities employing
persons providing care and payors for care, including the State and the Medicaid program; and

 Make recommendations, together with any necessary
implementing legislation, on the subject of registration of personal care and support workers providing services in homes,
assisted living centers, residential care facilities and supported living facilities; and be it further

Sec. 5. Staff assistance. Resolved: That the Department of Human Services shall provide staffing assistance; and be it further

34 Sec. 6. Voluntary service. Resolved: That the members of the task force shall serve without compensation or reimbursement of any type; and be it further

38 Sec. 7. Report. Resolved: That the task force shall submit its report, together with any necessary implementing legislation, 40 to the Joint Standing Committee on Health and Human Services and the Second Regular Session of the 118th Legislature no later than 42 January 1, 1998. If the task force requires an extension, it may apply to the Legislative Council, which may grant the extension.

**Emergency clause.** In view of the emergency cited in the preamble, this resolve takes effect when approved.'
