Check of Home Care Providers to Ensure Safety for Citizens Receiving
Care in Community-based Settings.**

2 **Sec. 1. Task force established. Resolved:** That the Task Force on
3 Criminal Background Checks for Home Care Providers, referred to
4 in this resolve as "task force," is established to study the
5 implementation of a statewide criminal record check of home care
6 providers to ensure the safety of citizens receiving care in
7 community-based settings; and be it further

8 **Sec. 2. Task force membership. Resolved:** That the task force
9 consists of the following 7 members:

10 1. The Commissioner of the Department of Human Services or
11 the commissioner's designee;

12 2. The Commissioner of Public Safety or the commissioner's
13 designee;

14 3. One member of the Joint Standing Committee on Health and
15 Human Services, appointed by the chair of that committee;

16 4. One member of the Joint Standing Committee on Criminal
17 Justice;

18 5. One representative of the Home Care Alliance of Maine;

19 6. One representative of an assisted living center,
20 appointed jointly by the President of the Senate and the Speaker
21 of the House of Representatives; and

22 7. One representative from Alpha One; and be it further

23 **Sec. 3. Appointments; meetings. Resolved:** That all appointments
24 must be made no later than 30 days following the effective date
25 of this resolve. The Executive Director of the Legislative
26 Council must be notified by all appointing authorities once the
27 selections have been made. Within 15 days of the appointment of
28 all members, the Chair of the Legislative Council shall call and
29 convene the first meeting of the task force. The task force
30 shall select a chair from among its members; and be it further

31 **Sec. 4. Duties. Resolved:** That the task force shall:

32 1. Examine laws from other states, including, but not
33 limited to, Alaska, Colorado, Florida, Nevada and Oregon
34 concerning criminal record checks of home care providers;

35 2. Obtain relevant reports and other data from states
36 listed under subsection 1 to evaluate the effectiveness of
37 criminal record checks;
