SENATE AMENDMENT "M" to COMMITTEE AMENDMENT "A" to H.P. 832, L.D. 1137, Bill, "An Act Making Unified Appropriations and Allocations for the Expenditures of State Government, General Fund and Other Funds, and Changing Certain Provisions of the Law Necessary to the Proper Operations of State Government for the Fiscal Years Ending June 30, 1998 and June 30, 1999"

Amend the amendment in Part S in section 3 in the first line (page 257, line 47 in amendment) by striking out the following: "University of Maine" and inserting in its place the following: 'Maine Technical College'

Further amend the amendment in Part S in section 3 in the 6th and 7th lines (page 258, lines 2 and 3 in amendment) by striking out the following: "University of Maine System for the Maine Economic Improvement Strategy" and inserting in its place the following: 'Maine Technical College System for the purpose of increasing enrollment'

Further amend the amendment by inserting before the emergency clause the following:

PART XX

Sec. XX-1. Appropriation. The following funds are appropriated from the General Fund to carry out the purposes of this Part.

16 1997-98 and fiscal year 1998-99 for the Maine Economic  
Improvement Strategy and appropriates \$250,000 each fiscal year  
18 to the Maine Technical College System's Career Advantage program  
and the Maine Quality Centers program.

20 This amendment also removes the authority for the Maine  
22 Economic Development Strategy to receive up to \$2,000,000 from  
available balances at the close of fiscal year 1997-98 and  
24 substitutes the purpose of increasing enrollment at the Maine  
Technical College System in its place.
