SUMMARY

This amendment strikes from the committee amendment the following:

1. The transfer of up to \$2,100,000 to pay the Maine State Retirement System for the cost of early retirement incentives
offered by the school administrative units of Jay, Scarborough, York, S.A.D. 25, S.A.D. 52, S.A.D. 56, School Union 29 and School
Union 30;

- 12 2. The transfer of up to \$2,000,000 to the Department of Transportation toward the purchase of Sears Island;
- The transfer of up to \$2,000,000 to the University of
 Maine System toward the Maine Economic Improvement Strategy;

 The transfer of funds to support 2 Assistant District Attorney positions in York County; and

5. The provision of funding necessary to establish a family 22 division within the Judicial Department.
