18 COMMITTEE AMENDMENT "H" to H.P. 899, L.D. 1216, Bill, "An 20 Act to Allow the Separation of Frye Island from the Town of Standish"

Amend the bill by inserting after the title and before the 24 enacting clause the following:

'Mandate preamble. This measure requires one or more local units of government to expand or modify activities so as to
 necessitate additional expenditures from local revenues but does not provide funding for at least 90% of those expenditures.
 Pursuant to the Constitution of Maine, Article IX, Section 21, two thirds of all of the members elected to each House have
 determined it necessary to enact this measure.'

34 Further amend the bill in Part A in section 1 in the 10th and 11th lines (page 1, lines 14 and 15 in L.D.) by striking out 36 the following: "November 1, 1997" and inserting in its place the following: 'July 1, 1998'

Further amend the bill in Part A in section 2 in the 5th 40 line (page 1, line 24 in L.D.) by striking out the following: "October 3, 1997" and inserting in its place the following: 42 'October 14, 1997'

44 Further amend the bill in Part A in section 3 in the last line (page 2, line 7 in L.D.) by striking out the following:
46 "November 1, 1997" and inserting in its place the following: 'July 1, 1998'

Further amend the bill in Part A in section 4 in the 9th 50 line (page 2, line 17 in L.D.) by striking out the following: "November 1, 1997" and inserting in its place the following: 52 'July 1, 1998'

Further amend the bill in Part A in section 5 in the 4th line (page 2, line 27 in L.D.) by striking out the following: "November 1, 1997" and inserting in its place the following: 'July 1, 1998'

Further amend the bill in Part A in section 6 in the 3rd 8 line (page 2, line 36 in L.D.) by striking out the following: "November 1, 1997" and inserting in its place the following: 10 'July 1, 1998'

12 Further amend the bill in Part A in section 6 in subsection 1 in the 4th line (page 2, line 42 in L.D.) by striking out the 14 following: "November 1, 1997" and inserting in its place the following: 'July 1, 1998'

Further amend the bill in Part A in section 6 by striking 0 out all of subsection 2 (page 2, lines 46 to 50 and page 3, lines 1 to 4 in L.D.) and inserting in its place the following:

 '2. Town of Standish taxes that are due from Frye Island
 property owners as of July 1, 1998 will continue to be owed to the Town of Standish after separation. Tax liens on behalf of
 the Town of Standish attributable to those taxes remain valid.'

26 Further amend the bill in Part B by striking out all of section 2 and inserting in its place the following:

'Sec. B-2. Agreement binding. Negotiation under section 1 of
this Part must be completed by September 22, 1997. The agreement
must be reduced to writing and is final and binding on the Town
of Standish and the Town of Frye Island upon incorporation of the
Town of Frye Island as of July 1, 1998, if the referendum
question in Part A is approved.'

36 Further amend the bill in Part C in section 1 in the last line (page 4, line 42 in L.D.) by striking out the following: 38 "November 1, 1997" and inserting in its place the following: 'July 1, 1998'

Further amend the bill by inserting at the end of Part C and 42 before the summary the following:

 44 'Sec. C-6. Transfer of Frye Island Municipal Services Corporation assets. The Frye Island Municipal Services Corporation shall
 46 transfer any assets remaining in the corporation at the time of repeal of its charter to the Town of Frye Island.

Sec. C-7. P&SL 1975, c. 138, as amended, is repealed.

Sec. C-8. Effective date. This Part takes effect upon incorporation of the Town of Frye Island pursuant to Part A of this Act, except that section 7 takes effect 2 years after the date of incorporation.'

Further amend the bill by inserting at the end before the summary the following:

'FISCAL NOTE

12 This bill includes several requirements on the Town of Standish including holding a special referendum for the residents of Frye Island and allocating debts and assets. The additional costs of this state mandate can not be determined. Pursuant to the Mandate Preamble, the two-thirds vote of all members elected to each House exempts the State from the constitutional requirement to fund 90% of the additional local costs.'

SUMMARY

22 adds a mandate preamble, changes The amendment the separation date from November 1, 1997 to July 1, 1998 and changes the referendum date from October 3, 1997 to October 14, 1997. It 24 also removes the requirement for binding arbitration on issues not resolved by a certain date and changes the date for resolving 26 agreements through negotiation to September 22, 1997. Finally, it repeals the charter of the Frye Island Municipal Services 28 Corporation 2 years after the incorporation of the Town of Frye 30 Island and requires that all assets of the corporation remaining at the time of repeal be transferred to the Town of Frye Island 32 and adds a fiscal note to the bill.
