2 The bill provides General Fund appropriations to the Maine Center for Arts Education program established within the Department of Education of \$81,800 and \$363,400 in fiscal years 4 1997-98 and 1998-99, respectively. The appropriation for fiscal 6 year 1997-98 includes funding for a program coordinator and administrative support and for planning, recruiting, site location and public relations expenses. The fiscal year 1998-99 8 appropriation also includes funding for teacher salaries and benefits and facility costs. These appropriation amounts are 10 based on budget information presented by the center and represent funding for the school and student institute. 12 Additional appropriations, in amounts which can not be determined at this time, may be required in fiscal year 1998-99 for student 14 transportation and other costs associated with operating the 16 school.

18 The bill also provides General Fund appropriations to the Maine Arts Commission of \$75,000 in each of fiscal years 1997-98 20 and 1998-99, respectively, for the cost to administer and provide training to artists and teachers through the Professional 22 Development Institute.'

SUMMARY

This amendment alters the status of the Maine Center for Arts Education from a charter school to a public school. To accomplish this, the amendment directs the board of trustees to consult with the Department of Education in developing the center's budget, permits the hiring of teachers who are not certified, revokes the provision allowing the center to grant diplomas and requires that the trustees report annually to the Governor.

36 The amendment also establishes that the board of trustees, in conjunction with the Maine Arts Commission, shall administer 38 the professional development institute of the center so that professional development programs reach teachers in all parts of 40 the State. Finally, this amendment adds a fiscal note to the bill.
